



MINUTE OF JURY SELECTION

Call for Post-Doctoral Research Fellowship Project Lymphocyte Development and Leukemogenesis, I-410948.01 (funded by the Calouste Gulbenkian Foundation)

On the 18th of May of 2023, at 14:00, the selection jury formed by Dr. Vera Martins, Dr. Karina Xavier and Dr. Claudia Campos, met to analyse the applications to a Post-Doctoral Research Fellowship in the scope of the project Lymphocyte Development and Leukemogenesis, I-410948.01, funded by the Calouste Gulbenkian Foundation.

The call was open from 17th of March 2023 until 30th of April 2023. The jury analysed the documents submitted in the applications. The call received 6 applications from the following candidates that were checked for the eligibility criteria defined in the call:

The eligible 4 candidates were classified first with basis on the CV and previous relevant experience (35%) and the motivation letter (15%). The vote for the classification was unanimous among juri members as follows:

Comments from the juri – Both interviewed candidates were excellent, with different skill sets and it was difficult to differentiate between them in the overall score.

If the candidate declines the position, the position will be offered to the candidate that scored in the second position, i.e. Dr. Bruna Sabino.
