



## MINUTE OF JURY SELECTION

Call for the **Postdoctoral Research Fellowship** of the Project 101116029-META\_FUN-ERC-2023-StG, entitled "Mapping metabolic responses to understand coexistence and community functioning", financed by Horizon Europe.

On the 29<sup>th</sup> February 2024, at 9 am, the jury selection formed by Dr Giulia Ghedini, Dr Marco Fumasoni and Dr Charlotte Briddon, met for analysing the applications for the postdoctoral fellowship mentioned above, in the scope of the project 101116029-META\_FUN-ERC-2023-StG, entitled 'Mapping metabolic responses to understand coexistence and community functioning", financed by Horizon Europe.

The call was open from 23<sup>rd</sup> January 2024 until 28<sup>th</sup> February 2024. The jury analysed the documents included in the applications found attached to these minutes.

The call received 8 applications that were classified with the following way:

After considering all applications, the jury convened to interview candidates 1 and 2 because of their strong motivation letters, relevant research experience in phytoplankton experimental ecology. We requested reference letters for candidates 1 and 2 – both candidates had outstanding reference letters.

Candidate number 3, while having relevant experience, has not finished the PhD degree yet and thus cannot be considered for this call. Candidates 4, 5 and 6 received their PhD over three years ago, thus are not eligible for this fellowship. Candidate 7 does not have relevant experience in the laboratory. Candidate 8 did not present a convincing cover letter and motivation for joining the lab.

The interviews occurred via Zoom on 7<sup>th</sup> March 2024 between 2 and 4 pm. Following the interviews, the jury decided by unanimity to recommend the hiring of candidate number 1 based on her PhD work on phytoplankton population dynamics under varying environmental regimes, and familiarity with ecological theory relevant to the project.





The candidates were classified in the following way:
